In July, our Executive Director, Bill Panzarino, and I had the privilege of attending the ADA Conference Week at the ADA headquarters in Chicago. The focus of this year's conference was the implementation of Fonteva Salesforce, a cutting-edge operational platform that has replaced the outdated Aptify system. This transition marks a significant step forward for the American Dental Association and all its component societies.

The new Fonteva Salesforce platform promises to revolutionize how we serve our members. You can look forward to a more streamlined process for entering and tracking your continuing education credits, among other improvements. This upgrade reflects our commitment to embracing technological advancements that enhance our members' experience and operational efficiency.

Artificial Intelligence in Dentistry

Another highlight of the Chicago meeting was the enlightening discussion on artificial intelligence (AI) in dentistry. As we stand on the brink of a technological revolution, it's clear that AI will dramatically reshape our practice methods.

AI in dentistry holds immense potential across various areas:

- Diagnostic Assistance: AI algorithms can analyze dental images with remarkable accuracy, potentially detecting issues that might be overlooked by the human eye.

All AEDs Are NOT Equal (Why The One You Have Matters) By Erik Zalewski, MS, NRP, CIC Chief Emergency Expert, Have Dummy Will Travel, Inc.

Approximately 79% of documented Sudden Cardiac Arrest (SCA) victims initially present with either ventricular fibrillation (VF) or ventricular tachycardia (VT)-- heart rhythms that can be detected, treated, and potentially reversed with an automated external defibrillator (AED). An unknown number of additional victims may present with supraventricular tachycardia (SVT)-- a rhythm that can also be treated and potentially reversed with an electrical shock that is delivered at a particular moment in the cardiac cycle, but not by most AEDs in dentist offices today. Why?

When the New York State Dental AED Law (S2923) went into effect more than 12 years ago, dentists were burdened to purchase another costly device that would (hopefully) collect dust in their offices. The market was extremely competitive, and to survive such low margins, vendors were forced to popularize only bare-bones AEDs. In fact, the Philips Onsite and FRx units were sold without an additional set of electrode pads or a spare battery— items that were recommended to be included by the manufacturer (See Product Manual p. A-1) and thus a MUST for regulatory compliance. Even the larger case needed to hold these items was an upsell. AEDs with advanced technology (including the ability to recognize and properly treat SVT) didn't stand a chance in the market.

Now, all of these AEDs are out of warranty. Some are no longer manufactured or supported. Genuine batteries and pads are no longer available. AED owners no longer enjoy any indemnity protection from the manufacturer. Many units are no longer in compliance with the original law, others may not even turn on. Just like any other electronic device, old AEDs and/or their aftermarket accessories will one day fail, possibly becoming the difference between life and death for someone. Fortunately for you, this is only enforced by civil litigation—and perhaps Signa.

Dr. Romanos is a Professor of Periodontology at Stony Brook University (SBU), School of Dental Medicine (SDM). Professor (Prof. Dr. med. dent.) of Oral Surgery/Implant Dentistry in Frankfurt/Germany; he is a former Associate Dean for Clinical Affairs and Director of Laser Dental Education at SDM; Fully trained in Periodontics, Prosthodontics, and Oral Surgery (Germany, USA); Board Certified in Oral Surgery and Implant Dentistry in Germany; Diplomate by the American Board of Periodontology; He is currently the Past President of the IADR Laser and Biophotonics Group, the Implantology Research Group of the IADR; the Academy of Osseointegration Foundation; Fellow of American Association for Dental Research, the Academy of Osseointegration, Int. College of Dentists, ICOI, ITI Foundation, Pierre Fauchard Academy; American Soc. Laser Medicine and Surgery, Great of NY Academy of Prosthodontics, Int. Academy Dental Facial Esthetics and the American College of Dentists.

Professor Romanos has global educational and research activities and served as Visiting Professor and Scholar in Brazil, Italy, Spain, Malaysia, and Utah/USA. He is the author of more than 450 publications, and book chapters (h-Index: 85; over 23,000 citations), top 2% of scientists worldwide according to the AD scientific index 2022, 2023; editor and co-editor in eight dental books, guest editor of the Periodontology 2000, volume 81 on Risks and their Prevention in Implant Therapy" and has been a dynamic speaker in more than 700 presentations (> 50 countries); Recipient of numerous scientific awards like the Distinguished Scientist Award from the American Academy of Periodontology (AAP) and the T.H. Maiman Award for Excellence in Dental Laser Research by the Academy of Laser Dentistry. Professor Romanos is the recipient of numerous international research grants, research mentor of more than 300 mentees worldwide and participant in many scientific organizations as a board member or had various leadership roles. He is well known for his international concepts of immediate loading based on animal and clinical studies and author of two books in this field

In addition, to research and scholarly efforts, he is actively involved in training, clinical and didactic teaching in periodontology, oral surgery, implant-, and laser dentistry in NY and Germany and practices in NY clinically in periodontology, implant-, and laser dentistry.

quality patient care and safety. As ADA president Linda Edgar says "Get informed about legislative issues... take action on the issues affecting our community".

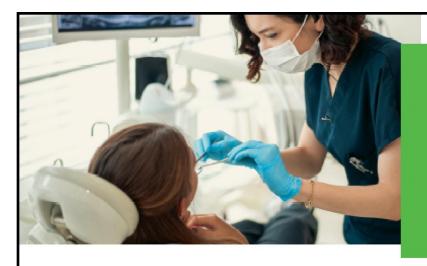

Sixth Letter from the ADA Trustee to the NYSDA Components - September 2024 - Trustee's Corner

Greetings New York State Dental Association members. Thank you for continuing to support our great profession of dentistry, as well as organized dentistry. I hope everyone and their families enjoyed this past summer. As many of you have heard, the American Dental Association has sold the building at 211 E Chicago Avenue in Chicago, Illinois. By way of history, the ADA bought the land at that site from the American Red Cross and built the current building in 1965. The new owners are the Ann and Robert Lurie Children's Hospital, which has their main headquarters next door. They rented four floors in our building for many years. We were also able to agree to rent from them while lease-hold improvements are done at our new location.

Our new headquarters will be located at 401 N Michigan, approximately a half mile from our previous location. We will occupy the top four floors of the building, floors 32-35. The leasehold improvements will be completed by early 2025 and we will move in right after. I was fortunate enough to have a tour of the facility in August. It is the perfect amount of space for our needs today. Approximately 70,000 square feet split between the four floors will be specifically built out for our volunteer member and staff needs. The view from all these floors is spectacular. You get a bird's eye view of the Chicago River, Lake Michigan, the Chicago Tribune and NBC buildings, as well as downtown Chicago. There are several excellent hotels right near our location, including the Sheraton and Regency.

There is also conference space to use on the 19th and 25th floors. In addition, there is a large conference center, the Gleacher Center, right next door and owned by the University of Chicago Booth School of Business. We will be able to lease it with planned events and large meetings. It reminds me of the Hillenbrand Auditorium on the second floor at the ADA building.

Ultimately, the ADA will be rightsizing to the exact amount of space needed for today. All our scientific laboratories will be in Boston, Massachusetts and many of our employees work from home or on a hybrid schedule. The ADA needed to right size its headquarters and these deals provided the perfect avenue for it. We also feel Lurie Children's Hospital was the right buyer who will have even more success continuing to carry on the tradition of providing local citizens with excellent health care.

Incidentally, the leased premises for our ADA Forsyth Institute (AFI) will be completed by the spring of next year. We are occupying approximately 76,000 square feet in a beautiful building in Somerville, a suburb of Boston. We have increased our grant amounts for 2024 to \$36 million dollars, with \$10 million of that coming from NIH grants. The synergy from this merger between the ADA and the Forsyth Institute has been incredible. Plans are in the works to take the capacity of the ADA Seal Program to another level. The demand is there for more consumer products looking for the Seal approval and the new labs will give us the means to achieve it. The AFI Certification Program, recently approved by the ADA Board of Trustees, will be introduced in the beginning of next year to approve specific dental products that dentists use in their office. The AFI feels there will be a strong demand for this certification program for dental manufacturing companies to meet the test of the program. Our members need to know which dental products on the market have been certified to do the things they profess.

On another note, the ADA just completed filing an amicus brief with the US Supreme Court concerning the Employee Retirement Income Security Act (ERISA). We are hoping this contributes to solving the confusion that certain dental insurance companies can claim they are under ERISA instead of state law and regulations. In general, some insurance companies, especially self-funded ones, proclaim they are immune from state insurance laws and regulations due to ERISA exemptions. Two different circuit courts, the Eighth and the Tenth, have given conflicted rulings on this very important issue. The ADA and several other health associations feel the Supreme Court needs to settle this area of law. We are hoping they decide in our favor sometime early next year.

It is really an exciting time for the ADA. With brand new headquarters and a new science laboratory location, it is indeed a time of change and implementation at the American Dental Association. As your second district trustee, I am humbled and proud to be part of the decision-making process in these historic times. I know I will see some of you at our annual meeting in New Orleans this October. We will be deciding critical issues as part of the House of Delegates. SmileCon will be celebrated right before our deliberations, and I hope many of you can come to NOLA to participate in some wonderful continuing education and meet up with many of your colleagues.
